

### Where Voters Stand: The American Jobs Plan and the Commitment to Clean Energy

Key findings from an online survey among 1,204 voters nationwide, conducted April 13 to 17, 2021 for Climate Power and LCV





### **Key Findings and Strategic Points**

- The AJP is in a strong position, with voters favorable to it by better than two to one—and that is with its price tag attached.
- Voters are supportive of the corporate tax increase as a pay-for especially if it is in the context of rolling back the excessive and wasteful corporate tax cut that was passed in 2017.
- Favorability for individual components is very high (mostly in excess of 60%), and voters are at a minimum favorable to each component by a margin of two to one.
- Clean energy components are popular and the inclusion of clean energy investments make them more likely to support the AJP overall.



### **Key Findings and Strategic Points**

- We have a highly compelling clean energy story to tell, with jobs—both short *and* long term—at the center of it. One key comparative advantage of clean energy jobs is that they are sustainable jobs, that will be with us for a long time.
- The climate benefits are important to our core base, and including climate in the core message does not turn off other voters. But for everyone other than liberal Democrats, the selling point is all about jobs, and that needs to continue to be the centerpiece of our communications.
- There are effective rebuttals to the main attacks on the plan, and after voters hear both sides of the debate there continues to be a large majority of voters who say Congress should pass the AJP.







#### Joe Biden's Job Approval in Selected Areas




More voters give the economy a positive rating than in February, but the large majority still rate economic conditions in less favorable terms.

February 2021\*







More Important Focus for the President and Congress on the Economy



























## Providing the context of 2017's corporate tax cut is essential in talking about the AJP pay-for.







Cost Of Electricity from Wind/Solar Power vs. Fossil Fuels (natural gas, oil, coal)




Biggest Benefits of Wind and Solar Power



### We have multiple, good, concrete examples of AJP-related projects to point to in communications.

Favorable Reaction<sup>\*</sup> to Aspects of President Biden's American Jobs Plan

The American Jobs Plan will employ plumbers, excavators, and other tradespeople to replace 100% of the nation's lead pipes and service lines and to modernize drinking water, wastewater, and stormwater 70% systems across America. All 50 states have drinking water infrastructure projects that are ready to begin work.

The American Jobs Plan will employ people who work on power lines and other technicians to build a more resilient electric transmission system to improve the availability of clean, renewable electricity. Modernizing **69%** our nation's electricity systems will prevent more disasters like the failure of the Texas electric grid, which resulted in the deaths of more than 200 people and left millions without water and power.

The American Jobs Plan will create construction jobs fortifying our existing critical infrastructure, such as electrical equipment and water systems, against the impacts of extreme weather and climate-related 68% disasters such as wildfires, hurricanes, and flooding.

The American Jobs Plan will employ people who work on power lines and other technicians to build a more 67% resilient electric transmission system to improve the availability of clean, renewable electricity.



The American Jobs Plan will create construction jobs to fortify our existing critical infrastructure, such as electrical equipment and water systems, against the impacts of extreme weather- and climate-related disasters such as wildfires, hurricanes, and flooding. For instance, this includes rebuilding highways, such as the National Scenic Byway in North Carolina, that have been damaged by rising sea levels, tropical storms, and hurricanes every year. 64% The American Jobs Plan invests in the Civilian Climate Corps to put a new generation of Americans to work conserving our public lands and waters, planting trees, and addressing the changing climate. These jobs will be all across our country from rural communities to urban areas.



The American Jobs Plan will put people to work installing and repairing train tracks, signals, and rail cars to address Amtrak's repair backlog and improve inter-city rail transportation. Amtrak has proposed a repair and expansion plan that would bring inter-city rail service to up to 160 new communities across the country, including Phoenix, Arizona; Columbus, Ohio; Nashville, Tennessee; and Las Vegas, Nevada.



The American Jobs Plan will **employ oilfield and mining workers to plug abandoned oil and gas wells and clean up abandoned mines** in order to put a stop to uncontrolled methane leaks and protect communities from toxic chemicals. This could potentially include hundreds of wells in Colorado and North Dakota, hundreds of thousands of wells in Texas, New Mexico, and Pennsylvania, and thousands more in other states.

The American Jobs Plan will employ solar installers, wind turbine technicians, electricians, construction workers, and many other workers to **build the capacity to deliver clean**, **renewable electricity**. Examples include a new solar and wind farm in Coconino County, Arizona and a new solar project near Trinidad, Colorado.

## **Responding to COST Criticism: Focus on the low—and declining—cost of renewables.**

**CONSUMER COST CRITICISM:** This plan will hit the American people right in their wallets. It will force them into expensive electric cars, electricity will cost more, and the price of everyday goods will go up because it will cost manufacturers more to make things. All at a time when people are already struggling to recover financially from the pandemic.

## Responding to RELIABILITY Criticism: Focus on successful examples and the 15-year time horizon; calling out Big Oil is not effective.

**RELIABILITY CRITICISM:** This plan begins to shift the United States to having all of our electricity generated by sources like wind and solar power—sources that are too unreliable for our needs. When the wind doesn't blow and the sun doesn't shine, electricity cannot be generated.

<b>LONG TRANSITION:</b> The transition to electricity from renewable sources will happen over the next 15 years, not immediately. ## Responding to GND/CULTURAL Criticism: It is most effective to cite the benefits to everyone.

**GND/CULTURAL CRITICISM:** This plan is supposed to be about infrastructure, but most of it goes to paying for a wish list of liberal policies that have nothing to do with infrastructure, like forcing people into smaller, less powerful electric cars, getting rid of jobs in the natural gas and coal industries, and trying to fix the overblown climate "crisis." This proposal is no different from the Green New Deal: a plan designed for socialists and California liberals, but forced on the rest of us.

## Responding to GOVERNMENT SPENDING/TAXES Criticism: No clear strongest response; "we can't afford to wait" is nominally more effective.

**GOVERNMENT SPENDING/TAXES CRITICISM:** Federal government spending is through the roof over the past year, including the nearly \$2 trillion spending bill that Congress just passed. The federal deficit is at an all-time high, and eventually people's taxes will be increased in order to pay for all of this. We simply cannot afford this new multi-trillion-dollar spending plan.

## Responding to JOB KILLING Criticism: Talking about worker training is a very strong response for those neutral to AJP.

**JOB KILLING CRITICISM:** This plan destroys tens of thousands of good-paying, middle-class jobs in the coal and oil industries. Joe Biden has already started killing these jobs by canceling the Keystone oil pipeline.

## Responding to TAXING BUSINESS Criticism: No clear winner or loser response; the best defense is to go on offense and give corporate tax history as context.

**TAXING BUSINESS CRITICISM:** Paying for this plan relies on a massive tax increase. Tax cuts a couple years ago brought our economy to a 50-year high before the pandemic. By hiking taxes on job-creating businesses, Joe Biden will bring our economic recovery to a halt while so many families are still struggling.
