2024 FOCUS AREAS

Thanks to the generosity of donors like you, our partnerships with the 30+ state affiliates in the Conservation Voters Movement (CVM), and our unique and multifaceted approach to protecting people and the planet, LCV is a national leader in the climate, environmental, and democracy movements. **Your support drove our success across four main areas in 2024:**



EQUITABLE & JUST CLIMATE PROGRESS

LCV bolstered clean energy advancements to reduce emissions and strengthened protections for people and communities from toxic pollution, climate-fueled extreme weather, and related health impacts. Our work emphasized correcting historic and disproportionate harms to Black, Indigenous, and Latine communities and other communities of color, as well as economically disenfranchised communities.

Across the CVM, we drove progress by mobilizing constituents, meeting with decision-makers, and organizing hundreds of thousands of community members. We defended climate progress from attacks by polluters' allies in Congress and state legislatures, held elected officials accountable for their climate-related votes, educated the media and the public, and pushed state and local decision-makers to take advantage of federal clean energy funds.



HEALTHY COMMUNITIES & PUBLIC LANDS

We continued advocating for policies to block the expansion of fossil fuel extraction, protect our nation's public lands and waters, strengthen and defend rules that reduce pollution, and provide communities with safe drinking water and equitable access to nature.

LCV worked alongside our 30+ state affiliates and our partners in the Equitable & Just National Climate Platform, and as part of coalitions with Tribes, Tribal-serving entities, and organizations led by people of color — leading to important public health and conservation wins across the country.



A STRONG REPRESENTATIVE DEMOCRACY

Alongside our 30+ state affiliates in the CVM, LCV continued advocating for a strong representative democracy — countering mounting threats to our nation's democratic institutions by protecting and expanding voting rights and promoting civic engagement at all levels of government.

Our approach included advocating for pro-democracy executive action, mobilizing constituents in support of legislation that would strengthen voting rights and protect elections, advocating for demographically and professionally diverse judicial nominees, recruiting community members to both work in and monitor our elections to ensure equity, and preparing diverse environmental champions to successfully run for state and local offices.



CLIMATE & DEMOCRACY CHAMPIONS

Despite losses in the 2024 elections, there were bright spots worth celebrating, especially in down-ballot races. LCV Victory Fund and affiliated entities across the CVM collectively engaged millions of voters, worked in support of thousands of candidates, and engaged 10,000 LCV members to volunteer.

The CVM connected with voters in person, by phone, and digitally, innovating to turn out voters and deliver victory to pro-environment candidates in the U.S. House and Senate, state legislatures, governorships, state judicial benches, and local races — even in battleground states where Trump won.

EQUITABLE & JUST CLIMATE PROGRESS

IRA PASSES KEY MILESTONE

The Inflation Reduction Act (IRA) is transforming our nation's energy economy, launching emissions-reducing wind and solar energy projects, and accelerating progress toward cutting U.S. climate pollution to 50% below 2005 levels by 2030. As of December 2024, the Biden-Harris administration was **on track to award over \$100 billion in IRA grants, more than 80% of available grant funds**, making those funds contractually protected. In addition, the IRA includes decade-long tax incentives for clean energy manufacturing and projects. These would require congressional action to terminate and bring the total investments provided by the law to well over the originally estimated \$369 billion, with some estimates as high as \$1 trillion.

The IRA, which was enacted in 2022, is the nation's largest-ever investment in climate action and clean energy. Passing such a momentous bill took **more than a decade of work by LCV, our state affiliates, and climate activists across the country**. Thanks to support from donors like you, we've continued to defend the IRA from attacks in Congress and to work with state and local leaders to roll out its benefits across the country.

Our state affiliates and LCV helped people and communities understand and access IRA benefits by hosting hundreds of events with elected officials, creating educational tool kits and websites, and knocking on 1 million doors in Georgia, Michigan, Montana, Nevada, Pennsylvania, and Wisconsin.

STATES ADVANCE CLEAN ENERGY

States continued to implement bold climate solutions and enact policies driving the clean energy transition — propelled in large part by the expertise and tenacity of our state affiliates. Thanks to policies won by LCV's **Clean Energy for All campaign** since 2018, more than 40% of people in the U.S. now live in places committed to 100% clean energy. In 2024, **we won progress in 31 states**, including expanding access to solar and wind power, securing critical investments in the electric grid, holding utilities accountable to keep consumer costs low, winning community protections from fossil fuel pollution, and deploying transformative federal investments from the IRA.

Notably, Vermont committed to achieving 100% clean energy by 2035 and became the first state to **make the world's largest fossil fuel companies pay for climate damages**, which will provide critical funding for disaster response and community adaptation and resilience projects. Massachusetts passed a massive climate omnibus bill to decrease emissions by increasing clean energy production and phasing out the use of fossil fuels. And Colorado **enacted air quality standards** for oil and gas extraction that will benefit people living in disproportionately impacted communities.

To secure these and scores of additional state victories, we mobilized more than 141,000 people across the CVM, held more than 4,700 meetings with decision-makers, organized events attended by more than 29,000 people, and knocked on more than 1 million doors to educate people about the IRA and its available benefits.



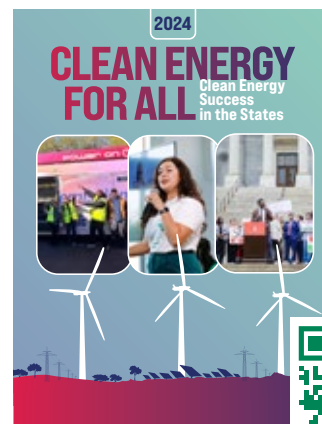

RED LAKE NATION'S SOLAR POWER TRANSITION

Residents of Minnesota's Red Lake Nation have long lamented their troubles with the local electric co-op and its high prices. Ever since Darrell G. Seki Sr. first campaigned to become Red Lake's chairman in 2002, he had regularly gotten an earful about it.

By the time Seki was reelected in 2022, he had a clear plan to bring clean, affordable solar energy to the community. His plan has since progressed, with rooftop solar installed at Red Lake's government and workforce development centers, and a community-wide solar solution in the works.

The planned utility-scale solar project, made possible by the IRA, will provide enough clean electricity to power the homes of everyone on the Red Lake Nation Reservation. The 200-acre project will provide emissions-free electricity for all 5,500 residents along with enough power to sell — creating a new revenue stream for the Tribe.

The Red Lake Tribe has maintained sovereignty over their land and people since first migrating from the northern Great Lakes area to what is now Minnesota in the 17th century. They are well on their way to achieving their next goal — energy sovereignty through the use of clean energy.

FORGING PARTNERSHIPS TO HARNESS WIND ENERGY

The impact of burning fossil fuels is such a serious health threat that several leading hospital systems in New England have endorsed offshore wind to help protect public health. At the same time, this region of the country holds enormous offshore wind energy potential — with winds stronger than almost any in the world.

LCV's New England state affiliates are at the forefront of a movement to responsibly harness the region's offshore wind energy. Together, they launched the New England for Offshore Wind coalition, which includes over 100 environmental groups, labor unions, fisheries, businesses, and other stakeholders. This powerful coalition is focused on **advancing equitable and sustainable offshore wind development** that benefits local communities and builds a strong green economy.

Thanks to the New England for Offshore Wind coalition's work, billions of dollars in investments, including funding from the IRA, are now flowing to New England's offshore wind projects. These clean energy projects are helping to create **tens of thousands of good-paying jobs** and tapping into wind sources capable of providing **enough energy to power every home and business in the region ten times over**. They're also eliminating carbon emissions equivalent to taking 20 million gasoline-powered cars off the road each year.

FAIR MAPS FOR WISCONSIN

For more than 13 years, Wisconsin's state legislative maps were so heavily **gerrymandered to reflect partisan interests** that they essentially silenced the voices of voters and guaranteed one-party control of the state legislature. That changed in **February 2024, when new fair and responsive maps were signed into law**, giving every voter in the state a long-overdue say in who represents them.

Over the years, Wisconsin Conservation Voters engaged constituents on this issue, **mobilizing people in support of fair courts and generating public comments, testimony, and legislator contacts** to advance fair redistricting.

In 2024, Wisconsin picked up **four pro-democracy and pro-environment seats in its Senate**, providing an opportunity to achieve a pro-democracy and pro-environmental trifecta in 2026.

BUILDING A BALANCED JUDICIARY

LCV, our state affiliates, and our allies continue to advocate for judicial nominees committed to equal justice for all, not just polluters and other powerful special interests. In 2024, we and our partners mobilized constituents to send **tens of thousands of messages** to Capitol Hill in support of judges who work for the people, not polluters. They include **Judge Nicole Berner**, who has been a leading lawyer for workers' and reproductive rights, has worked to advance **voting rights, civil rights, and immigrants' rights**, has worked pro bono for children in abuse and neglect cases, and has been a leader for LGBTQ+ rights. She is **the first openly LGBTQ+ judge to serve on the U.S. Fourth Circuit Court of Appeals**.

FROM LCV VOLUNTEER TO ELECTED OFFICIAL

When she announced her candidacy for the Monterey County (California) Board of Supervisors, Kate Daniels didn't expect the campaign to be so toxic. Even in today's political climate, when her two male opponents published demeaning altered photos, lies, and conspiracy theories about her online, she was taken aback. But, **Daniels leaned into her solid campaign plan and won** — despite these attacks.



Daniels had previously enrolled in LCV's Candidate Academy, which trains pro-climate action and pro-democracy potential candidates to run for office. **Thanks to the training, Daniels kept her eyes on the prize, focusing on her plan**, gaining an early fundraising start, winning key endorsements, and meeting every voter possible. **"Learning from the training what I had to do was huge ... Campaigns are a science, and the training provided the steps that allowed me to complete my campaign successfully,"** said Daniels.

Years before attending the Candidate Academy, Daniels had volunteered for LCV's state affiliate, California Environmental Voters, calling folks to urge their support of pro-environment candidates. Since then, she's enjoyed a successful career in public service. As the newly elected Monterey County supervisor, **Daniels will be working across the agricultural, tourism, and housing sectors to create sustainable economic opportunities** for her constituents.

CLEANER AIR

Headaches. Cardiovascular and respiratory failure. Cancer. People living in low-wealth communities and communities of color have **historically experienced higher rates of these emissions-induced illnesses** due to the proximity of polluting industries, transportation hubs, and highways to their homes, parks, and schools.

New federal, state, and local clean energy and transportation **policies and projects are now helping to reduce these health risks in communities across the country.** Improvements include reductions in coal production, decreased methane pollution from the oil and gas sector, lowered emissions from wood heaters and power plants, and the deployment of hundreds of thousands of electric vehicles.

To secure these wins, LCV and our state affiliates mobilized communities, educated lawmakers, advocated for policies that protect air quality, and held officials accountable to take meaningful action. **All of this adds up to cleaner air, better health, and improved lives.** One mother from Modesto, California, whose children now ride electric school buses, noted, "I'm not hearing complaints about headaches; we have fewer doctors' appointments, and less use of inhalers."

LEAD-FREE WATER

Safe drinking water is a fundamental human right, yet **more than 9 million lead pipes are still delivering unsafe water to households across the country** decades after their dangers became clear. The health risks from lead exposure — which include brain damage, kidney impairment, and cardiovascular issues — are especially high in low-income communities and communities of color. That will soon change.

In late 2024, the Biden-Harris administration announced a final Environmental Protection Agency (EPA) rule **requiring drinking water systems to replace lead pipes** across the country — along with the funds needed to complete the work **over the next decade**.

LCV and our state affiliates have been pushing for action on lead pipes for years, using a variety of effective approaches to achieve the strong final EPA rule, including educating lawmakers, mobilizing thousands of LCV-member actions and public comments, and engaging directly with EPA officials alongside our state affiliates.

The resulting rule will save lives and improve public health, especially in the communities that are disproportionately affected. The EPA estimates that the rule will **prevent low birth weight in up to 900,000 infants and avoid up to 1,500 premature deaths** from heart disease each year.

The 2024 election results were not what we worked so hard for. The resulting Trump presidency will bring new attacks on our bedrock environmental protections and democratic rights. And yet, **it's crucial not to overlook the climate and democracy victories won further down the ballot**, where LCV Victory Fund and affiliated entities made a difference by engaging voters in key races.

Victories in state-level races will mean opportunities to continue building on the significant climate action progress our movement has already made. Consider that at the start of Trump's first term, 1% of people in the U.S. lived in places committed to 100% clean energy. Now, over 40% of the country does. That's entirely due to state action, and state leaders have proven they are capable of taking up the mantle for climate action.

Despite major headwinds, LCV Victory Fund's field and paid media programs **helped hold on to four of the most competitive U.S. Senate seats**, even in states where Trump prevailed: Arizona, Michigan, Nevada, and Wisconsin. LCV Victory Fund, LCV Action Fund, and LCV's GreenRoots program also helped **elect and re-elect 129 pro-climate, pro-democracy U.S. House candidates**, holding the Republican majority to its lowest seat margin in decades.

The 2023-2024 state and federal wins outlined below mean that we can keep progress alive to shape what comes next.



LCV Victory Fund works with our allies and state affiliates to persuade and mobilize voters to help elect climate champions to federal and state offices. LCV Victory Fund's broad reach elevates climate action as a critical electoral issue, positions us as a trusted messenger along with our state affiliates and other partners, and ultimately helps pro-environment candidates win.

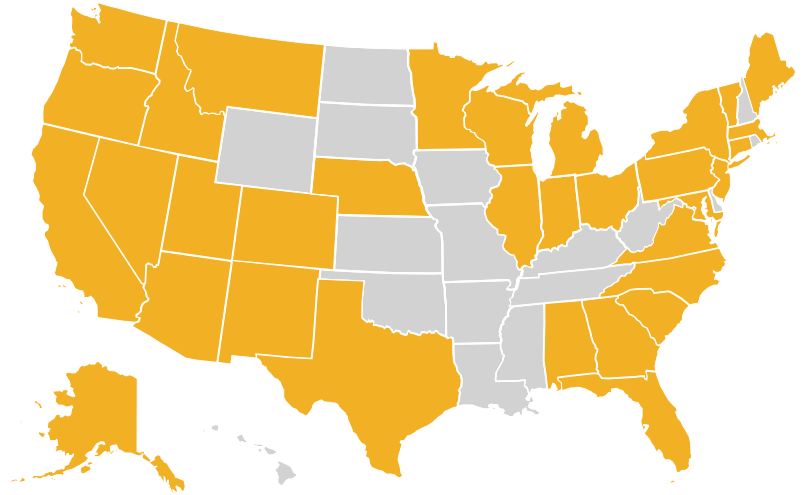

THE POWER OF 30+ STATE AFFILIATES

The partnerships between LCV Victory Fund and state affiliates is unique and critical to our success. By working together, we're able to reach and mobilize people in communities across the country to help elect climate and democracy champions up and down the ballot.



A DIRTY DOZEN FIRST: A BALLOT INITIATIVE

Washington Ballot Initiative I-2117

Washington voters defeated one of the worst attacks on climate action in the country, strongly rejecting an effort to roll back the state's ambitious climate plans. **62% of voters stopped efforts to dismantle the state's carbon market**, which has generated over \$2.15 billion for green projects, such as electric vehicle rebates, air quality initiatives, and clean energy infrastructure. Initiative 2117 was so important that it was included in LCV Victory Fund's 2024 *Dirty Dozen in the States*, which typically highlights 12 of the worst candidates in the nation at the state and local levels each election cycle. The addition marked the **first time a ballot initiative has ever appeared on this list**, bringing the *Dirty Dozen in the States* to a baker's dozen of 13.

FEDERAL ELECTIONS

SENATE WINS

Pro-environment candidates prevailed in U.S. Senate races in presidential battleground states, despite the headwinds at the top of the ticket. LCV Victory Fund ran field programs in key races, knocking on doors and connecting with voters to help these climate champions win their Senate seats:

INNOVATING FOR THE FUTURE

In times of rapid change, innovation matters. LCV Victory Fund and our state affiliates are committed to testing new approaches to reach voters and help elect climate and democracy champions. In 2024, we built on our long-standing commitment to innovation to spearhead new strategies that proved successful in many races and will serve as a springboard for future work.

Paid Relational Organizing

Friend-to-friend voter outreach typically relies on volunteers. After testing a paid version of this tactic in 2023, **LCV Victory Fund put it to work at scale in 2024**, holding 35,000+ conversations among friends, family, and neighbors in Arizona, Michigan, Montana, Nevada, North Carolina, Pennsylvania, and Wisconsin. These efforts helped engage hard-to-reach voters and contributed to pro-climate victories.

Youth Vote Efforts

In 2024, LCV Victory Fund and affiliated entities employed new digital efforts to reach young voters — a demographic whose vote was key to delivering decisive margins of victory to pro-climate, pro-democracy candidates in 2020 and 2022 — and voters who rely on non-legacy media to inform their political decisions. We partnered with more than 20 diverse content creators, social media influencers, and public figures who regularly reach millions of people to help engage voters online.



Door Knocking in Key House Districts

When competing in U.S. House races, most large campaign organizations direct resources almost exclusively to paid ads. In 2024, instead of relying solely on ads, LCV Victory Fund expanded our best-in-class canvassing operation to include U.S. House races. Our approach was **based on results from a successful pilot project** we ran in the NY-03 special election earlier in the year. In total, we knocked on 1.3 million doors in 12 U.S. House districts to help elect climate and democracy champions to the U.S. House.

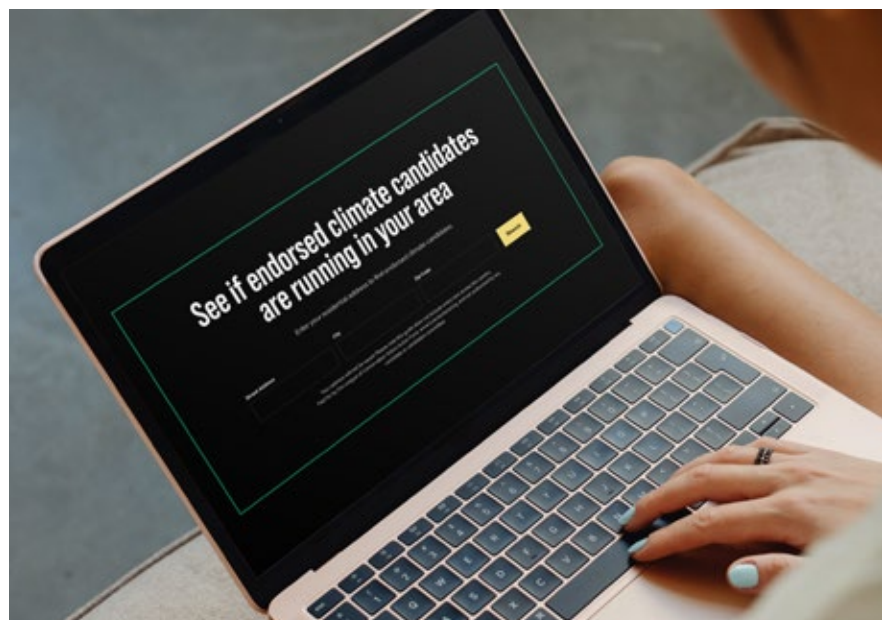

Climate Candidate Guide

This election cycle, LCV Action Fund announced the launch of its first-ever Climate Candidate Guide. This user-friendly tool let **voters enter their addresses to find endorsed pro-environment candidates** up and down their specific ballots. The guide also included resources to help voters check their registration status and find their polling locations. The guide featured 1,790 candidates in 42 states and was used by 87,000 people.

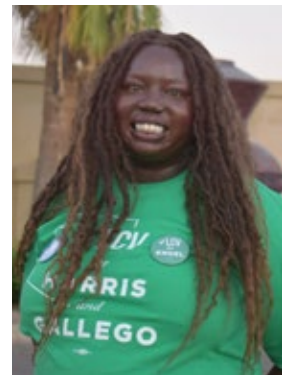

FROM REFUGEE TO ENVIRONMENTAL JUSTICE ADVOCATE

When Achol was five years old, her family fled the civil war in Sudan and immigrated to Buffalo, New York, one of the most impoverished cities in the U.S. There, Achol and her family faced a new set of challenges, including a lack of access to green space and ongoing exposure to pollution. After witnessing these challenges and the related health issues faced by her community, Achol became involved with environmental justice advocacy and other political causes in college.



In 2024, Achol worked as an LCV GreenRoots organizer in Phoenix, knocking on doors, making phone calls, and connecting with voters in support of pro-environment candidates up and down the ballot — including Arizona's Ruben Gallego, who won his seat in the U.S. Senate.

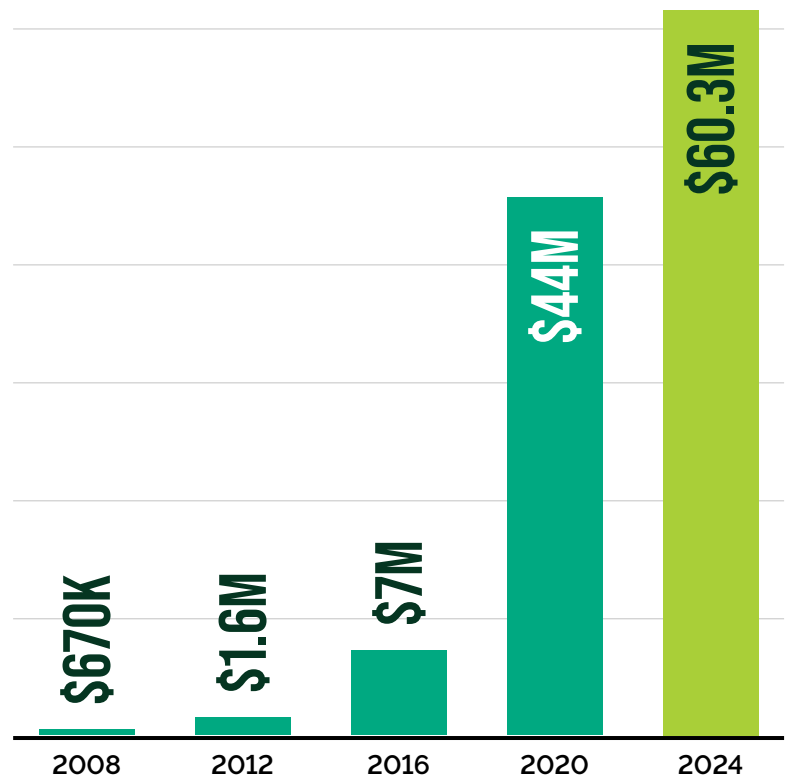
